





2	Ground (GND)	
3	Output	The output is DC coupled. Most commonly used with external coupling capacitor. 0.001 to 0.01μF recommended
4	V _{CC} Supply Voltage	Connect an appropriate 10nF power supply bypass capacitor as close as possible

For Optimum Jitter Performance, Pletronics recommends:

- A ground plane under the device
- Do not route large transient signals (both current and voltage) under the device
- Do not place near a large magnetic field such as a high frequency switching power supply
- Do not place near piezoelectric buzzers or mechanical fans
- Minimize air flow across the device






Reflow Cycle


