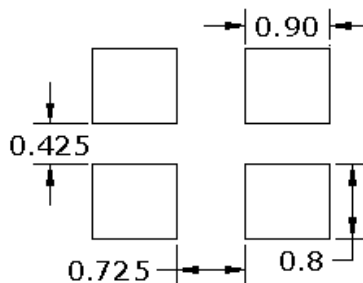

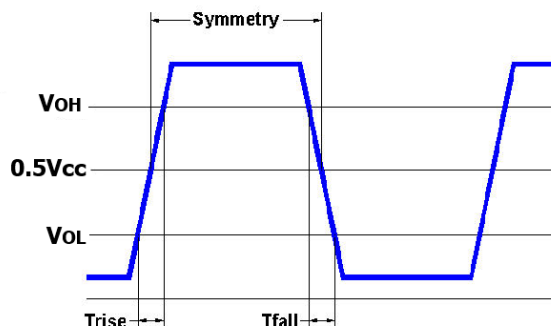
Electrical Test / Load Circuit

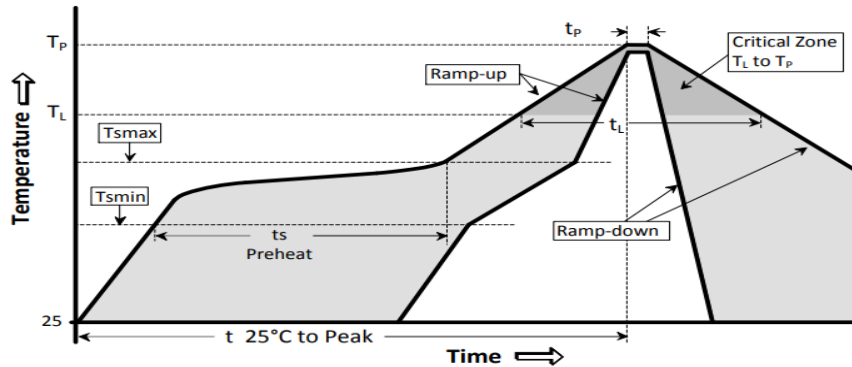

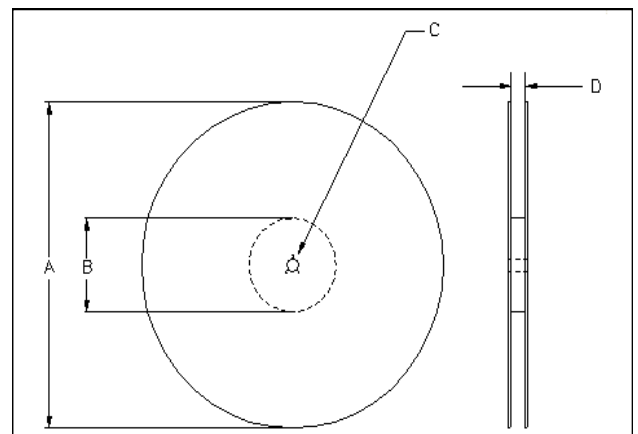
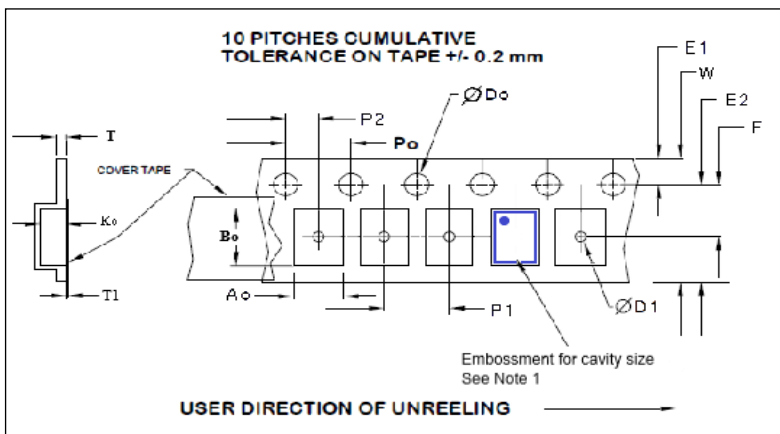
